**887 Woburn, LLC
Draft Authorization to
Construct
Large C&D Processing
and Handling Facility at
887 Woburn Street,
Wilmington,
Massachusetts 01887**

Notice is hereby given, pursuant to M.G.L., Chapter 111, Section 150A and Section 150A1/2, that the Massachusetts Department of Environmental Protection, ("MassDEP") has prepared a Draft Authorization to Construct ("ATC") permit for a large solid waste handling facility (the "Facility") to be located on 887 Woburn Street, Wilmington, Massachusetts (the "Site"). The Site consists of approximately 3.37-acres of land that has been site-assigned for solid waste management activities by the Wilmington Board of Health. The proponent is 887 Woburn, LLC, 887 Woburn Street, Wilmington, MA 01887.

887 Woburn, LLC is proposing to construct a large C&D solid waste handling and processing facility that would handle up to 500 tons per day and a maximum of 182,500 tons per year of construction and demolition debris ("C&D"). The facility will accept and sort C&D materials within an enclosed 35,312 square-foot handling building using both manual and mechanical recovery methods. Sorted materials will be consolidated for export. The proposed Facility will include a handling building, weigh scales, sound attenuation fence, a scale house, employee breakroom, bathrooms, offices, and railroad tracks. The driveways and parking areas of the Facility will be paved. Stormwater run-off from the Facility will be collected in a series of catch basins, treated, and discharged. The facility proposes to operate 24 hours per day and 7 days per week. Inbound materials will be restricted to Monday through Friday 5:00 AM to 7:00 PM and Saturdays from 5:00 AM to 1:00 PM.

The application and draft permit may be reviewed at the Wilmington Board of Health located at 121 Glen Road, Wilmington, MA 01887 during regular business hours Monday through Friday 8:30am – 4:30pm. MassDEP will accept written comments on the draft decision for a period of 30 days following the date the public notice is first published.
